Voting Rights and Capital

The following notification is made in accordance with the UK Financial Conduct Authority's Disclosure Guidance and Transparency Rule 5.6.1.

At close of 31 October 2021 the issued share capital of Standard Chartered PLC consisted of:

3,079,119,100 ordinary shares of US\$0.50 each with voting rights of one vote for every US\$2 nominal value;

99,250,000 8¹/₄ per cent non-cumulative irredeemable preference shares of £1 each with no equity voting rights;

96,035,000 7³/₈ per cent non-cumulative irredeemable preference shares of £1 each with no equity voting rights;

7,500 6.409 per cent non-cumulative redeemable preference shares of US\$5 each with no equity voting rights;

7,500 7.014 per cent non-cumulative redeemable preference shares of US\$5 each with no equity voting rights.

The total number of voting rights in Standard Chartered PLC as at 31 October 2021 was 769,779,775. Ordinary shareholders have one vote for every four ordinary shares they hold (equivalent to one vote for every US\$2 nominal value of ordinary shares). This figure for the total number of voting rights may be used by shareholders as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change to their interest in, Standard Chartered PLC under the UK Financial Conduct Authority's Disclosure Guidance and Transparency Rules.
