Strong First Month Revenue Results – Seaweed Sales Business (Indonesia)

Highlights

- **Total revenue of A\$ 150,646 for the period 14 May to 15 June 2025 comprising:**
 - **Export Revenue: US\$61,949 (A\$ 95,400)**
 - **Local (Indonesian) Revenue: IDR586,347,695 (A\$ 55,246).**
- **Customer Base: Initial sales were made to wholesale buyers in South Korea and Indonesia.**
- **Operations: Seaweed sourced through local partnerships with coastal farming communities in the Nunukan region of Indonesia, supporting the Company's sustainability and community engagement commitments.**

The Board of BPH Global Ltd (**ASX: BP8**) is pleased to report the initial revenue results from its new seaweed sales operations in Indonesia, following the commencement of trading activities in May 2025. The business, which sources, processes, and exports sustainably harvested seaweed, recorded approximately A\$ 150,646 in gross revenue during its first month of operations. This early performance reflects encouraging demand across key regional markets and underpins the commercial potential of the Company's seaweed operations.

Managing Director Matthew Leonard said: "We are encouraged by the strong start to our Indonesian seaweed venture. The response from customers has exceeded our expectations and validates our investment in this growing sector. As we scale up production and secure trade financing and new offtake agreements, we are confident of building a robust revenue stream aligned with our sustainability values and global market trends".

Trading Results

During the period 14 May to 15 June 2025, the Company generated total revenue of approximately A\$150,646 from seaweed sales, comprising:

- **Export Revenue: US\$61,949 (A\$ 95,400); and**
- **Local (Indonesian) Revenue: IDR586,347,695 (A\$ 55,246).**

These initial sales were made to wholesale buyers in both Indonesia and South Korea, demonstrating early traction with both domestic and international customers. All sales were conducted under the Company's [previously announced Sales Cooperation Agreement with PT Kebula Raya Bestari](#). Export

sales were made to South Korea-based food ingredient manufacturer MSC, Ltd., including the initial transaction [previously disclosed](#). Local sales were made to Indonesia-based PT Surya Seaweed Indonesia, also including the initial transaction [previously disclosed](#).

Seaweed was sourced through established partnerships with local farming communities in the Nunukan region of Indonesia, ensuring traceability and responsible harvesting practices. These relationships are core to the Company's commitment to environmental sustainability and community development.

The operational focus remains on scaling volumes to meet growing demand while maintaining product quality and strengthening market presence. The Company is actively engaged in negotiations for additional offtake agreements and expects trading volumes to increase over the coming months.

The Company intends to provide the market with monthly updates on its seaweed sales volumes in Indonesia.
