# COLDry Fertiliser Project Receives EPA Approval

# **Highlights:**

- EPA pilot licence (G02 Coal Processing Approval) granted to ECT for COLDry Fertiliser Project
- Major regulatory milestone for Zero Quest joint venture between ECT and ESG Agriculture
- The next regulatory milestone is local government planning approvals, expected in coming weeks

Environmental Clean Technologies Limited (ASX: ECT) ("ECT" or "Company") advises that the Environment Protection Authority Victoria (EPA) has granted pilot project licence number PPL000300015 for the COLDry Fertiliser Project at Bacchus Marsh.

Issued under section 78(1)(a) of the *Environment Protection Act 2017*, the licence authorises the staged construction and operation of a pilot-scale facility to produce a low-emission, lignite-based fertiliser. Activities covered include the low-temperature co-drying of brown coal and urea blends, and the subsequent production of fertiliser granules from COLDry pellets.

### ECT CEO John Tranfield commented:

"The pilot project licence is a key milestone in the progress of the COLDry Fertiliser Project. This approval represents 16 months of detailed and dedicated work by our team, marking a significant step forward for the Zero Quest joint venture."

ECT will provide further updates as the project advances toward financial close and construction commencement.

# **About the COLDry Fertiliser Project**

Zero Quest Pty Ltd, a joint venture between ECT and ESG Agriculture, is developing the COLDry Fertiliser Project to offer a sustainable and cost-effective alternative to conventional nitrogen fertilisers. Using ECT's proprietary COLDry technology, the process blends lignite with nitrogen-based inputs to improve nutrient retention, reduce nitrogen loss, and limit runoff into waterways, enhancing both productivity and environmental performance.
