## **Second Month Revenue Results – Seaweed Sales Business (Indonesia)**

### **Highlights**

- **Total revenue of A\$177,316 (IDR 1,886,526,000) for the June Sales Period (15 June – 14 July 2025)**
- **Represents a 17.7% increase on the May Sales Period (14 May – 15 June 2025)**
- **Customer Base: Sales were made to wholesale buyers in Indonesia, with international shipments currently in progress for the July Sales Period**
- **Operations: Seaweed sourced through local partnerships with coastal farming communities in the Nunukan region of Indonesia, supporting the Company's sustainability and community engagement commitments.**

The Board of BPH Global Ltd (**ASX: BP8**) is pleased to report the revenue results for the second month of trading from its new seaweed sales operations in Indonesia, which commenced in May 2025. The business — which sources, processes, and exports sustainably harvested seaweed — recorded approximately A\$177,316 in gross revenue during June 2025 reporting period (compared to [A\\$150,646 in May 2025](#)). This early performance reflects encouraging, sustained demand and underpins the commercial potential of the Company's seaweed operations.

Managing Director Matthew Leonard said: "We are further encouraged by the continued strong performance of our Indonesian seaweed venture. Customer interest remains high, and as we scale up production and progress trade financing and offtake discussions, we remain confident in building a robust and sustainable revenue stream aligned with our values and global market trends."

### **Trading Results**

During the period 15 June to 14 July 2025, the Company generated total revenue of approximately A\$177,316 (compared to A\$150,646 in the previous reporting period).

Sales during this period were made to wholesale buyers in Indonesia, demonstrating continued traction with domestic customers. Sales to international customers are currently being executed and will be reflected in the July reporting period, supporting ongoing international market engagement. All sales in this reporting period were conducted under the Company's [previously announced Sales Cooperation Agreement with PT Kebula Raya Bestari](#).

Seaweed was sourced through established partnerships with local farming communities in the Nunukan region of Indonesia, ensuring traceability and responsible harvesting practices. These

relationships remain central to the Company's commitment to environmental sustainability and community development.

The operational focus remains on scaling volumes to meet growing demand while maintaining product quality and strengthening market presence. The Company is actively engaged in negotiations for additional offtake agreements and to secure trade financing, and expects trading volumes to increase over the coming months.

The Company will continue to provide monthly updates on sales volumes from its Indonesia-based seaweed operations.
