InVert Graphite Demonstrates Consistent High-Grade Graphite Over 2km Strike

Over 30% TGC graphite from Kumba Deposit at Morogoro

HIGHLIGHTS

- Results from a further three trenches at the Kumba deposit at Morogoro have returned wide zones of high-grade graphite at surface including:
 - o 68m @ 18.7% Total Graphitic Carbon (TGC) in trench TRUM23-004
 - including 30m @ 21.9% TGC with up to 27.1% TGC, and
 - 84m @ 15.2% in trench TRUM23-003
 - including 6m @ 27.5% TGC and up to 31.4% TGC, and
 - 88m @ 14.0% TGC in trench TRUM23-005
- Results from a further three trenches at Kasanga are pending.
- Drill site access underway for an initial Reverse Circulation (RC) drilling program to follow up the high-grade trench results.
- New US Commerce Department to impose 93.5% anti-dumping duties on Chinese graphite imports.

InVert Graphite Limited (ASX: IVG), (InVert or the **Company)** is pleased to report further trench results from the Kumba deposit at the Company's Morogoro Project in Tanzania. The Company has excavated five trenches at Kumba and three at Kasanga. This release reports results from another three trenches from Kumba with two previously reported on 17th July 2025.

Based on the favourable results from Kumba, the Company has mobilised an RC drill rig to test for mineralisation at depth below the trenches.

InVert's Chief Executive Officer, Andrew Lawson, commented:

"The latest trench results from Kumba demonstrate a consistently high-grade mineralisation at surface that is now confirmed to extend over a 2km strike.

"These results reinforce our confidence in the scale and quality of the Morogoro Project, and highlight the potential for a significant, high-grade graphite system from surface.

"With trench results also pending from Kasanga, we are advancing drill access preparation at Kumba and look forward to commencing our maiden RC program shortly to follow up on this early trenching success."



Morogoro Project

InVert Graphite (ASX: IVG) is an Australian company focused on exploration and development of critical minerals in Tanzania and South Australia. In January 2025, Dominion Minerals Limited (ASX: DLM) undertook a corporate transformation, renaming as InVert Graphite Limited and subsequently acquired 100% ownership of the Morogoro Project in Tanzania, as part of its readmission to trading on the official list of the Australian Stock Exchange.




Figure 1: The Morogoro project is located 25km south of the town of Morogoro and ~200km west of the Tanzanian commercial centre of Dar es Salaam.

Field work in 2022 to ground-truth historic mapping confirmed numerous graphitic schists over seven prospects and surface grab sampling results ranging from 5.7% TGC up to 30% TGC.

Orientation metallurgical testwork comprising of a standard grind and flotation and cleaning process was completed on five samples from the Kumba and Kasanga occurrences providing concentrate grades up to 98%.

Field mapping and grab sampling at Kumba had identified broad zones of outcropping and inferred graphitic schist over a strike length of approximately 2km. Trenches were dug on approximately 500m spacings with samples collected for assay (Figure 3 and Photo 1).






Figure 2: Morogoro Project, Prospect locations and surface grab samples for graphite. Dashed box is location of Figure 3.

Trench Results

Five trenches for 1,105 metres in length were completed at the Kumba deposit and a further three trenches for 1,397 metres at the Kasanga deposit.

Initial results¹ were previously released from two trenches, TRUM23-001 and TRUM23-002, which returned broad zones of mineralisation with **312m zone at 8.8% TGC including 30m at 12.2% TGC** from 120m in trench TRUM23-001 and **140m at 14.1% TGC** from 18m, including a higher-grade zone of **60m averaging 17.4% TGC** in TRUM23-002 1km to the west.

Results have now been received from the remaining three trenches at Kumba.

Trench TRUM23-003 is located approximately 300m to the west of the previously released TRUM23-002 and returned **84m @ 15.2% TGC** from 0m including **6m @ 27.5% TGC** and including a **2m interval over 31.4% TGC**.

Trench TRUM23-004 is located between the previously released TRUM23-001 and 002, returning multiple zones with **64m @ 12.8% TGC** from 20m and **68m @ 18.7% TGC** from 224m, inclusive of **30m @ 21.9% TGC** from 226m with up to 27.1% TGC.

Trench TRUM23-005 is located approximately 750m to the north west of TRUM23-003 and is linked by a region of mapped graphitic sub-crop. TRUM23-005 returned **88m @ 14.0% TGC** from 12m.

In all trenches structural measurements indicate a shallow foliation dip of approximately 35° to the NNE. This dip angle indicates a true thickness of the units of approximately 60% of the outcrop width.






Figure 3: Kumba plan map showing trench locations. Trenches TRUM23-003, 004 & 005 in this release.

Further Work Programs

Samples from a remaining three trenches at Kasanga are at the laboratory with results pending.

Based on the trench results the Company has committed to the mobilisation of an RC drill rig to test for extensions at depth of the graphite mineralisation. Work is currently underway on track and drill pad access along with field camp establishment, with the drill rig expected to mobilise to site in the coming weeks.
