The estimated unaudited net tangible asset value (NTA) after tax as at 31 August 2025 was \$0.87<sup>1,3</sup> per unit (31 July 2025 was \$0.89<sup>1,3</sup> per unit).

The NTA movement recorded during the month (-2.2%) is primarily a result of foreign exchange losses due to the strengthening of the Australian dollar as well as minor negative asset valuation movements following receipt of all June 2025 quarterly valuations.
