

## Section 708A Notice

Alligator Energy Limited (the Company) (ASX:AGE) refers to the issue of 6,983,180 fully paid ordinary shares granted for quotation on 16 September 2025. This issue resulted from short-term incentive options held by employees vesting as a result of the 2024/25 KPI performance assessment process.
