## **SIMPEC awarded major procurement and construction contract**

### **Highlights**

- **SIMPEC has been awarded the Main Procurement and Construction Contract for the Residue Filtration Stage 2 Project at Alcoa's Pinjarra Alumina Refinery**
- **The project involves delivering infrastructure and services to increase processing capacity to convert bauxite residue into filter cake**

**WestStar Industrial Limited** (Company or WestStar) (ASX: WSI), an Australian industrial services company, operating in the energy, resources, utility and infrastructure sectors, is pleased to announce the award of a new contract, valued at approximately \$115 million, to its wholly owned subsidiary SIMPEC.

SIMPEC's Scope of Work includes the SMP E&I and Civil supply, construction and commissioning works for the Alcoa Pinjarra Alumina Refinery's Residue Filtration Stage 2 Project.

The infrastructure and services will increase processing capacity to convert bauxite residue – a by-product of refining bauxite into alumina - into filter cake. The conversion process removes a significant amount of the water content mechanically via filter presses, thus reducing the storage area compared with alternative residue drying solutions.

The project will commence immediately and is scheduled for completion in Q1 CY2027.

SIMPEC Managing Director Mark Dimasi noted:

*"Securing this major contract marks an important milestone in SIMPEC's growth journey. It further strengthens our reputation as a trusted partner for the safe and successful delivery of complex industrial projects, while showcasing our ability to execute multidisciplinary works to the highest standard.*
