



Saferoads Holdings Limited - Quarterly Activity Report.

Sales for the quarter have been encouraging with products sales at \$3,418k that includes \$1,675k to On-site Rentals (OSR) the entity that acquired our Road Safety Rental (RSR) business in May this year. The average monthly product sales other than those to OSR was \$581k compared to \$597k in the first quarter of the previous financial year. The unaudited underlying net profit for the quarter was \$346k. The OSR revenue for the second quarter is expected to be in line with the first quarter as we complete delivery of the \$3m order from them as previously advised. The profit for the second quarter is expected to be similar to the first quarter. Thereafter there is uncertainty on two key factors, our ability to gain market share following the strengthening of our sales team this quarter and the future level of product orders from OSR. Accordingly, the current level of quarterly profitability may not be sustained.

Operating Cashflow was a negative \$593k, primary due to an increase in inventory. Due to cashflow constraints, the products inventory levels were reduced leading up to the sale to OSR in May 2025 of the RSR business. The increase in inventory this quarter is bringing the business inventory holdings back to appropriate levels.

The expenses continue to be closely controlled with the only increase of note being the salaries for the expansion of our senior sales team. There is one R&D project for the next quarter, being the MASH crash testing in November of our HV2 barrier in a pinned format. This test has been computer modelled and was successful. We are hopeful that the physical test will also be successful. In its pinned format the market demand for this product will be more diverse and stronger.
