Fifth Month Seaweed Sales Results – Continued Growth and Operational Expansion

Highlights

- Gross sales of A\$226,947 (IDR 2,499,000,000) for the September Sales Period (15 September – 14 October 2025)
- Slight increase on previous month's sales of A\$222,656 (IDR 2,449,000,000)
- IDR 965,000,000 in sales achieved directly by PT BPH Global, independent of the Kebula collaboration
- Remaining sales made under the Company's existing Sales Cooperation Agreement with PT Kebula Raya Bestari
- PT BPH Global granted a Seaweed Export Licence by the Indonesian Government, enabling direct export of seaweed products
- Makassar warehouse fully operational and supporting expanded sourcing, processing, and sales activities across both operational frameworks
- Sales during the period were made to wholesale buyers in Indonesia; international shipments are expected in the coming months

The Board of BPH Global Ltd (**ASX: BP8**) is pleased to report the sales results for the fifth month of trading from its Indonesian seaweed operations, which commenced in May 2025.

For the period 15 September to 14 October 2025, BP8 generated gross sales of approximately A\$226,947 (IDR 2,499,000,000) based on fulfilled purchase orders with payments pending settlement under standard trading terms. This represents a modest increase on the [previous month's](#) A\$222,656 (IDR 2,449,000,000), maintaining the Company's consistent sales performance and upward trajectory in its early operational phase.

Operations

BP8's Indonesian subsidiary, **PT BPH Global**, continues to strengthen its dual operational framework — operating independently while also maintaining its collaboration with PT Kebula Raya Bestari. During the September reporting period, IDR 965,000,000 in gross sales were made directly by PT BPH Global, reflecting the growing capability of the Company's own sourcing, processing, and

distribution network. The remaining sales were completed under the existing Sales Cooperation Agreement with Kebula, reaffirming the complementary nature of both channels.

The Company also achieved a significant operational milestone during the period, with PT BPH Global obtaining a Seaweed Export Licence from the Indonesian Government. This key development authorises BP8 to export seaweed products directly, paving the way for the commencement of international shipments in the coming months.

Seaweed continues to be sourced through established partnerships with coastal farming communities in the Nunukan region of Indonesia. These relationships reinforce BP8's commitment to traceability, sustainability, and community engagement, ensuring that commercial growth aligns with the Company's environmental and social objectives.

The Makassar warehouse in South Sulawesi is fully operational, providing the infrastructure necessary for large-scale processing and sales. Equipped with a quality control laboratory, hydraulic press, and capacity of up to 1,000 metric tons per month, the facility supports both BP8's independent operations and its ongoing partnership with Kebula.

BP8 Managing Director **Matthew Leonard** said:

"This month's results reflect another solid performance for BP8, with overall sales slightly higher than the previous period and a significant portion now being achieved through our own operating subsidiary in Indonesia. The ability of PT BPH Global to generate independent revenue so early in its development demonstrates both the depth of our local capabilities and the value of our investment in infrastructure and personnel.

The granting of our Indonesian seaweed export licence marks a major milestone, positioning BP8 to commence direct export sales in the near term. This step enhances our commercial flexibility, opens access to international markets, and supports our broader strategy of developing a sustainable, vertically integrated seaweed business. We are pleased with the consistent performance of our operations and remain focused on expanding production volumes and building long-term customer relationships both domestically and abroad."

The Company will continue to provide monthly updates on sales volumes from its Indonesia-based seaweed operations.
