## Quarterly Activities Report – September 2025

Battery, base and precious metals exploration company Yugo Metals Limited (**ASX:YUG**) (**Yugo** or the **Company**) is pleased to provide its activities report for the quarter ended 30 September 2025.

### Highlights:

- **Post quarter end the Company announced a \$3.5M Placement to underpin gold focused diamond drilling program at Sinjakovo**
- **The Company continues with community consultations and discussions with the relevant Ministry about the issue of Sockovac (Petrovo) Exploration License**
- **Yugo is well-advanced in preparing for the upcoming exploration programs, and is ready to mobilise the field teams immediately upon the Petrovo tenement grant**

### Sinjakovo Project

Post quarter end the Company announced a \$3.5M Placement to underpin gold focused diamond drilling program at the Sinjakovo Project.

The funds raised from the Placement will be used towards the execution of Phase 1 of a diamond drilling program focused on defined gold anomalies. assay testing, geological modelling, and target refinement for Phase 2.




Figure 1: Plan map showing trenching results at Sinjakovo Project

The exploration targets are drill-ready and are the first-ever drilling over gold prospects at Sinjakovo. The planned drilling program is designed to validate the previous results from trenching (61m @ 1.5g/t gold and 21m @ 1.4g/t gold<sup>1</sup>, refer to Figure 1) and rock chip sampling (up to 8g/t gold and 4.5% antimony<sup>2</sup>), located within a 6km<sup>2</sup> gold-in-soil area discovered by Yugo Metals. A follow up in form of Induced Polarisation survey has returned strong shallow chargeability anomalies<sup>3</sup>, further strengthening the quality of gold-antimony exploration targets at Sinjakovo.

Drilling is expected to commence in November and finish by the end of 2025 with a 1,000m diamond drilling program planned. An epithermal gold-antimony system is with strong structural controls (early thrust-faults and late diatreme breccias) and favourable geology (quartz-porphyry intrusives within the carbonate rocks).

The program will comprise of 8 initial shallow drillholes up to 70m drilling depth, followed by several drillholes at 70-130m drilling depth (with the follow-up hole design being subject to visual observations from initial drillholes).

The drillhole details for the entire drilling program will be provided upon execution of the program.




Figure 2: Vertical section of Erak gold prospect, showing initial planned drilling

## Sockovac (Petrovo) Project

During the period, the Company continued with community engagement and consultations with local key stakeholders. The Company was engaged in consultations with the Government about the pending approval of the Petrovo tenement (10km<sup>2</sup>), encompassing the area with historical (1969) significant shallow drilling results on nickel (5.1m @ 6.6% Ni from 57.9m depth; cobalt not analysed) and zinc+lead (9.35m @ 8.2% Zn+Pb from 41.8m depth; silver and gold not analysed)<sup>1</sup>, and recently identified gold-silver mineralisation on surface with rock-chip results up to 5.7g/t gold and 1,330g/t silver<sup>2</sup>. The Company is optimistic about a favourable outcome and are in ongoing discussions with our advisors at the Ministry of Energy and Mining.

In addition, the Company is continuing to actively explore various prospects and assessing potential acquisitions in tier 1 jurisdictions that would be complimentary to the Company's asset portfolio and enhance shareholder value.




Figure 3: Sockovac (Petrovo) cross-section showing historical drill holes with interpreted geology

## Corporate

### Cash position and capital raise completed

Net cash outflow during the quarter was approximately \$0.3 million leaving the Company with a cash balance of approximately \$0.6 million as of 30 September 2025.

On 14 October 2025 the Company announced it had received firm commitments to raise \$3,500,000 (before costs) via a two-tranche placement (Placement) of 77,777,778 fully paid ordinary shares at A\$0.045 per share (Placement Shares). The issue price for the Placement represented a discount of 16.67% discount to the last close price (\$0.054). In addition, the Placement includes 1 free attaching unlisted option for every 2 shares applied for and issued under the Placement (Placement Options). The Placement Options will be exercisable at \$0.10 each, expire 3 years from the date of issue and will be subject to shareholder approval.

The Company utilised its capacity under ASX Listing Rule 7.1 (30,650,000 shares) and 7.1A (23,544,444 shares) to issue tranche one of the Placement Shares on the 22 October 2025. The Company will obtain shareholder approval for tranche two of the Placement (23,583,334 shares) at the upcoming AGM on 28 November 2025.

CPS Capital Group Pty Ltd acted as Lead Manager to the Placement (refer to the Company's Appendix 3B lodged on 14 October 2025 for details on the Lead Manager fees).
