The Glenaras Gas Project ("Project") (Figure 2) is located in ATP 2019, which is 100% owned and operated by Galilee.

The Permit covers an area of approximately 3,200km².

During the past quarter, operational activity was focused on monitoring the reservoir pressure for the Glenaras pilot to continue to expand our understanding of reservoir behaviour.

Continued to assess farm out options for funding the exploration programme for this permit.

Corporate

The Company's quarterly and year to date cash flow results for the period to 30 September 2025 are presented in the accompanying Appendix 5B report. In line with previous quarters, a disciplined approach to expenditure for the Glenaras Gas Project has been maintained for exploration and evaluation activities.

The Company continues to assess alternative commercial opportunities that have the potential to deliver significant growth and value creation. During the quarter the Board elected to not continue with the Novus engagement.

The Company's cash position as at 30 September 2025 of \$2.25 million and no debt. The Appendix 5B includes an amount in item 6.1 which constitutes director's fees paid in the September quarter.
