Update on ADR upgrade, Nasdaq uplisting

CLINUVEL today announced that it anticipates the ongoing U.S. Federal Government shutdown will impact timelines for review and approval of registration statements to be filed with the U.S. Securities and Exchange Commission (SEC). As part of a planned upgrade of CLINUVEL's American Depositary Receipt (ADR) program, the work continues to progress across legal, financial and regulatory workstreams in order to finalise a Form 20-F registration with the SEC.

As announced on 22 August 2025, CLINUVEL intends to upgrade its ADR program from Level I – listed on over-the-counter markets in the U.S. – to a Level II program trading on the Nasdaq Stock Market (Nasdaq), subject to SEC review and satisfaction of listing requirements.

Commentary

"Our team and partners are on track with our internal timelines for the necessary SEC filings," CLINUVEL'S Head of Australian Operations and Investor Relations, Mr Malcolm Bull said. "Feedback from the U.S. administration, however, indicates a longer than anticipated turnaround of filing reviews, which are likely to be conducted and completed only after the shutdown is resolved. We are optimistic that all compliance and listing requirements will be satisfied and will work diligently to minimise the impact of any regulatory delays resulting from the shutdown."

No final decision has been made in respect of the proposed ADR uplisting. The process also remains subject to SEC review and satisfaction of Nasdaq listing requirements. There is no guarantee that the uplisting will proceed, nor that it will occur within the expected timeframe. CLINUVEL will provide further updates to the market as material developments occur.
