

NOTICE OF SECOND COURT HEARING

Aurumin Limited (ASX:AUN) (Aurumin or the Company) provides the following update in relation to the proposed acquisition of 100% of the issued share capital of Aurumin by Brightstar Resources Limited (ASX:BTR) by way of a shareholders scheme of arrangement and a related optionholders scheme of arrangement (the **Schemes**).

Aurumin refers to the explanatory statement released to the ASX on 9 October 2025, which includes information about the Schemes and notices of Scheme meetings (**Scheme Booklet**).

TAKE NOTICE that at 4.00pm (AWST) on 19 November 2025,¹ the Supreme Court of Western Australia at Level 11, David Malcolm Justice Centre, 28 Barrack Street, Perth, Western Australia will hear an application by Aurumin seeking the approval of a scheme of arrangement between Aurumin and its shareholders (**Share Scheme**) and as between Aurumin and its optionholders (**Option Scheme**) proposed by resolutions to be considered, and, if thought fit, passed at the meeting of the shareholders of Aurumin to be held at 2.00pm (AWST) on 14 November 2025 (**Share Scheme Meeting**) and optionholders of Aurumin to be held at the later of 2.30pm (AWST) and the conclusion of the Share Scheme Meeting on 14 November 2025.

If you wish to oppose the application for approval of the Share Scheme or the Option Scheme, you must file with the Supreme Court of Western Australia and serve on Aurumin a notice of appearance, in the prescribed form, together with any affidavit on which you wish to rely at the hearing. The notice of appearance and affidavit must be served on Aurumin at its address for service at least 1 day before the date fixed for the hearing of the application.
