PC Gold Limited ACN 609 609 047 (ASX:PC2) - REQUEST FOR A TRADING HALT

The Directors of PC Gold Limited (**Company or PC Gold**) request that the Company's securities be placed in a trading halt prior to the commencement of trading on Monday 10 November 2025 in accordance with ASX Listing Rule 17.1, pending the release of an announcement by the Company in relation to material exploration results at the Company's Spring Hill Gold Project.

PC Gold provides the following information in relation to its request:

- 1. The trading halt is requested to assist the Company in managing its continuous disclosure obligations pending the announcement in relation to exploration results at its Spring Hill Gold Project;
- 2. PC Gold requests that the trading halt end on the earlier of the commencement of normal trading on Wednesday 12 November 2025, or when the anticipated announcement referred to in (a) above is released to the market; and
- 3. PC Gold is not aware of any reason why the trading halt should not be granted, nor of any other information necessary to inform the market about the trading halt.
