Due to the resignations of Ms Diana Heggie and Dr Paul Kasian, Resolutions 2 and 3 were withdrawn.

Resolution 7 (Conditional Spill Resolution) was withdrawn as it was conditional on at least 25 per cent of the votes on Resolution 1 being against that Resolution, which did not occur.
