Welcome fellow shareholders, to the 2025 AGM, and thank you all for your investment.

Introduction

Fiscal Year 2025 has seen us achieve several important milestones:

- It marks our 11th consecutive year of delivering profitable growth, reflecting our purpose to make a difference in markets that are underserved and overcharged.
- Our Cloud Services and Government businesses, aligned with the Australian Government’s focus on sovereign capabilities, security of critical infrastructure and cyber security investment, provided cyber security expertise to help secure our customers’ digital infrastructure, and protect them from the billions of threat events to their data every month.
- We also continued our strong partnerships with key vendors such as Microsoft, Dell and others to deliver innovative hybrid Cloud solutions for our customers.
- Our IC3SuperWest data centre development rose from the ground and is now a 7 story concrete shell sitting at the rear of our Macquarie Park Data Centre Campus. Over the next 10 months the base building systems will be fitted out and the first 6MW of capacity will come on line. We also installed the infrastructure for our second 45 MVA power feed so as to have 90MVA of power available upon opening of IC3 SuperWest.
- The Macquarie Telecom business has successfully evolved into a managed connectivity and network security business, and is a leader in SDWAN networks. It continued to deliver margin improvements and operational efficiencies contributing to our profitable growth, all while contributing significant free cash flow to the Group.
- Overall, we achieved an unparalleled customer experience Net Promoter Score (NPS) of +87.
- We were yet again voted a “Great Place to Work”, a “Best Place to Work” and a “Gallup Exceptional Workplace” all of which is no secret to our ~500 employees.
- As Peter mentioned, with our strong balance sheet and available funding, the Company is focused on bringing IC3 SuperWest to market and acquiring a new campus in Sydney to enable our growth plans and ensure capacity runway for our customers and prospects.
- With an experienced Executive and Management team leading our organisation, we look forward to 2026.

- Finally, I would like to join our Chairman in thanking Adelle Howse for her outstanding service as a non-executive director over the last 6 years. Adelle has worked tirelessly for the Company and has an incredible attention to detail. She has provided exceptional input into our strategy and investment cases and has made a significant contribution to the success of the Group. Adelle, we will miss your intellect and strategic thinking and we wish you well with your next endeavours.
