The release of this announcement was authorised by Joshua Quinn, Non-Executive Director and Company Secretary.

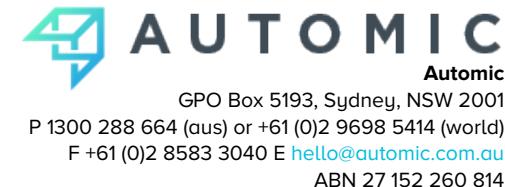
