NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS ACT

On 1 December 2025, Lachlan Star Limited (**ASX: LSA**) (**LSA** or the **Company**) completed Tranche two of the Placement by the issue of 6,600,000 fully paid ordinary shares in the capital of the Company (**Shares**) at an issue price of \$0.05 per Share (refer Appendix 2A lodged with ASX). The two-tranche placement was previously announced on 28th August 2025.
