The key terms are as follows:

- 1. Mr Swiridiuk (or his nominee) will receive remuneration for executive services provided to the Company on the basis of a maximum of \$2,500 (exclusive of GST) per day and \$1,250 (exclusive of GST) per half-day.
- 2. The arrangements are able to be terminated by either party on 14 days' written notice.
- 3. The interim arrangements are in place until 31 December 2025 (unless they are replaced or extended).
