ASX has advised to start a new electronic form as the processing of ASX online forms was interrupted on 1 December 2025. The Company confirms that between 18 March 2024 and 1 December 2025, 3,272,238 securities were purchased for a total consideration of \$34,005,136.67 as part of the buy-back.
