## NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS ACT

On 3 December 2025, WIN Metals Ltd (ACN 648 687 094) (ASX: WIN) (**Company**) issued 3,000,000 fully paid Ordinary Shares in the capital of the Company at a deemed \$0.02 per share (**Shares**). The issue of the Shares is in settlement of fees for corporate and investor relations services. The Shares were issued under the Company's Listing Rules 7.1 placement capacity.

The Corporations Act 2001(Cth) (**Act**) restricts the on-sale of securities issued without disclosure, unless the sale is exempt under section 708 or 708A of the Act. By the Company giving this notice, sale of the Shares will fall within the exemption in section 708A(5) of the Act.

  - (b) that investors and their professional advisers would reasonably require for the purpose of making an informed assessment of:
    - I. the assets and liabilities, financial position and performance, profits and losses and prospects of the Company; or
