**Dear Gary** 

Substantial Shareholding in EDU Holdings Limited

We refer to the substantial shareholding held by Mulpha Education Investments Pty Ltd (**Mulpha**) in EDU Holdings Limited (**EDU**) and our letter of 23 September 2025, published on the ASX on 24 September 2025.

On 1 December 2025 it was announced to the market that Mulpha had entered into a Selective Buyback Agreement with EDU for 10,000,000 EDU shares. This is subject to shareholder approval in early 2026.

Mulpha has since conducted on-market sales to reduce its holding in EDU as set out in Form 604, Notice of change of interests of substantial holder dated today, 8 December 2025. Accordingly, Mulpha no longer has an intention to remain a substantial shareholding in EDU.

Mulpha authorises the release of this letter to the Australian Securities Exchange.
