Kala Data Centre Generator Arrives in Botswana – Revenue Generation Nearing Commencement

Tlou Energy Limited (“Tlou” or “the Company”) is pleased to advise that, following significant global shipping delays, the generator for the Kala Data Centre has now arrived in Botswana. Transport of the unit to Tlou’s Lesedi project site is underway and is scheduled for completion in the coming weeks.

Upon arrival at Lesedi, the generator will be installed adjacent to the data centre facility and integrated with the gas gathering line connected to the Lesedi 4 production well. The generator will then be tied into the data centre infrastructure. Following installation, commissioning, and final operational checks, the data centre will commence operations.

The Company expects revenue generation to begin almost immediately once the facility is brought online. This milestone represents the first monetisation of coalbed methane in Botswana, an achievement that not only validates the commercial potential of Tlou’s gas resources but also demonstrates the Company’s technical capability in delivering innovative, on-site energy solutions.

Managing Director Colm Cloonan commented: *“The arrival of the generator marks a major step forward for the Company. We are now firmly on the path toward first revenue from the Lesedi project. This milestone will showcase the value of our gas resource and the viability of our development strategy. We look forward to updating shareholders as commissioning progresses.”*

Tlou remains committed to advancing the Lesedi project and unlocking further value from its extensive gas resources in Botswana as well as adding solar power generation.
