31st Copper Concentrate Shipment Dispatched

Perth, Australia: Alara Resources Limited (ASX: AUQ) (Alara or the Company), a base and precious metals producer and explorer with projects in Oman, is pleased to announce the dispatch of the 31st shipment of copper concentrate from its Al Wash-hi - Majaza copper-gold mine in Oman. The Al Wash-hi - Majaza mine is operated by Alara's joint venture company Al Hadeetha Resources LLC (AHRL). Alara holds a 51% interest in AHRL.

Key Highlights

31st shipment of 1409 WMT copper-concentrate shipped on 15th December, comprising 277.7 MT copper and 2.4 Kg gold

The Al Wash-hi Majaza copper-concentrate plant has achieved a production of 1409 WMT of copper-gold concentrate with approximately 277.7 MT of contained copper and approximately 2.4 kg of gold in its latest shipping cycle. This comprises the 31st parcel of copper-concentrate exported from the plant, and departed Sohar Port on 15th December 2025.

The reduction in the production cycle during the period was primarily due to a planned shutdown of the Al Wash-hi-Majazza copper concentrator plant undertaken by AHRL from 7th December to 15th December. The shutdown was carried out to facilitate the replacement of SAG mill liners along with other scheduled maintenance activities. These works were necessary to ensure safe, reliable, and efficient plant operations going forward, and resulted in a temporary curtailment of processing and production during the shutdown period. This is a scheduled downtime which had been factored in the annual budgets and projections.
