Cleansing Notice – Issue of Shares

Imagion Biosystems (ASX: IBX) (**Company** or **Imagion**), a company dedicated to improving healthcare outcomes through the early detection of cancer utilising its proprietary MagSense® imaging technology, lodges the following cleansing notice for the new ordinary shares issued pursuant to the conversion of notes under the Convertible Securities Agreement with Mercer Street Global Opportunity Fund, LLC (**Mercer**). Under the Mercer conversion notice received, the Company has issued today 8.0m ordinary shares at a deemed issue price of 2.5 cents each from the conversion of 200,000 convertible notes, as set out in the Appendix 2A released today. Following the issue of these shares, Mercer holds a balance of 2,826,212 Convertible Notes with the Company.

- (a) it issued 8,000,000 fully paid ordinary shares (Shares) on 15 December 2025;

- (e) as at the date of this notice, there is no excluded information of the type referred to in Sections 708A(7) and 708A(8) of the Corporations Act which is required to be disclosed pursuant to section 708A(6)(e).
