

NOTICE PURSUANT TO SECTION 708A(5)(E) OF THE CORPORATIONS ACT

Lindian Resources Limited (ASX:LIN) ("the Company") gives notice pursuant to section 708A(5)(e) of the Corporations Act 2001 Cth ('the Act') that on 19 December 2025, it has issued a total of 8,474,811 fully paid ordinary shares relating to the conversion of options exercisable at \$0.30 on or before 9 December 2025, following completion of an underwriting of the options.

 - i. the assets and liabilities, financial position and performance, profits and losses and prospects of the Company; or
 - ii. the rights and liabilities attaching to the Shares.
