

## CAPITAL RAISING COMPLETION

**Critical Resources Limited** ('Critical Resources' or the 'Company', **ASX:CRR**) announces that Tranche 2 of the Placement announced on 15 September 2025, has settled raising and additional \$385,000 (before costs), via the issue of 48,125,000 new fully paid ordinary shares, together with 24,062,500 attaching unlisted options (exe \$0.008, exp 23/04/28).

As previously announced, the Placement was being undertaken in two tranches, with the second tranche to participating Directors, to be issued subject to shareholder approval at a general meeting of shareholders satisfied on 5 December 2025. Please refer to the Notice of Meeting dated 6 November 2025 for further details.

In addition, as approved by Shareholders on 5 December 2025, the Company has completed the issue of 30,000,000 Managing Director (MD) Options to Mr Wither under the Company's Employee Securities Incentive Plan ('Plan'). A summary of the material terms of the MD Options and Company's Plan is outlined in the Notice of Meeting dated 6 November 2025.

The Company recognizes the importance of delivering appropriately structured incentives to eligible participants to align their interests with those of Shareholders of the Company. The Company's Employee Securities Incentive Plan has been designed to align performance to the Company's strategic objectives, and to retain, reward and attract talent over the longer term.
