The proposed buy-back is subject to Completion of the Transaction as detailed in the announcement dated 10 Dec 2024. Orora will only buy-back shares at such times and in circumstances as it considers beneficial to the efficient capital management of Orora and the buy-back is therefore dependent upon market conditions, volumes and other relevant factors.
