



Notice Under Section 708A(5)(e) OF THE CORPORATIONS ACT 2001 (Cth)

On 24 December 2025, Taruga Minerals Limited (**Company**) issued 1,200,000 fully paid ordinary shares (**Shares**) following the conversion of 1,200,000 unquoted options at an issue price of \$0.015 each.
