Notice under section 708A(5)(e) of the Corporations Act 2001 (Cth)

EPX Limited (ASX: EPX) (the “**Company**”) on 24 December 2025 issued 1,562,500 new fully paid ordinary shares in the Company (“**New Shares**”) to Kilara Growth Fund LP, at an issue price of \$0.32 per share. The New Shares have been issued in connection with the Deed of Company Arrangement concerning the Company’s acquisition of Wattwatchers Pty Limited, announced to ASX on 18 December 2025.
