## OFF-MARKET TAKEOVER BY FORRESTANIA RESOURCES LIMITED - NOTICE OF STATUS OF DEFEATING CONDITIONS

We act for Forrestania Resources Limited (ACN 647 899 698) (**Forrestania**) in respect of its offer dated 8 December 2025 (**Offer**) in relation to its off-market takeover bid for all of the fully paid ordinary shares in Kula Gold Limited (ACN 126 741 259) (**Kula**) pursuant to its replacement bidder's statement dated 4 December 2025 (as varied by the notice dated 23 December 2025), which replaces its bidder's statement dated 24 November 2025 (together, the **Bidder's Statement**).
