SECONDARY TRADING NOTICE PURSUANT TO SECTION 708A(5) OF THE CORPORATIONS ACT 2001 ("Act")

Galan Lithium Limited (**the Company** or **Galan**) advises that it has issued 101,492 fully paid ordinary shares (**Shares**) in the capital of the Company to and employee under the Galan Securities Incentive Plan (2022).
