HIGH-GRADE NIOBIUM DISCOVERED 400M OUTSIDE ARAXÁ MRE

81.5m @ 1.27% Nb₂O₅ from surface – including 43m @ 2.01% Nb₂O₅ from surface and grades up to 7.2% Nb₂O₅

- **World’s premier niobium location:** St George’s Araxá Project is in the Barreiro Carbonatite – an unrivalled world-class setting for niobium with CBMM’s industry-leading niobium mining operation situated immediately adjacent to St George’s project
- **New high-grade niobium discovery 400 metres to the northwest of the MRE:** Expansion drilling to the north and west of the existing resource footprint has discovered a new zone of high-grade niobium with multiple drill holes each intersecting **80 metres** plus of high-grade niobium from surface including discovery hole AXDD031 which returned assays of¹:
 - **81.5m @ 1.27% Nb₂O₅ from surface including:**
 - **43m @ 2.01% Nb₂O₅ from surface, and**
 - **10.5m @ 3.41% Nb₂O₅ from 17m**
- **Large upgrade to the niobium mineral system:** The new discovery supports potential to significantly expand the volume of the already world-class niobium and rare earths MRE² at the Araxá Project – which is open in all directions. Ongoing expansion drilling will include the area in and around AXDD031 which is emerging as a new niobium-rich zone at the project.
- **Niobium – the critical metal dominated by Brazil:** More than 90% of the world’s niobium is produced by Brazil³ with neither China nor the US having any domestic supply of this critical metal, making St George’s Araxá Project a globally significant niobium project that is sought-after by investors.
- **Drilling 24/7:** Expansion and resource definition drilling continues 24/7 with three diamond core rigs; 29 drill holes at the laboratory with assays pending.

St George Mining Limited (**ASX: SGQ**) (“**St George**” or the “**Company**”) is pleased to announce a significant discovery of high-grade niobium outside the existing MRE at its 100%-owned Araxá Rare Earths and Niobium Project in Minas Gerais, Brazil.

John Prineas, St George Mining’s Executive Chairman, said:

“These latest results again underscore the large scale and extensive continuity of the mineral system at Araxá and reinforce the setting of our project in the world’s leading niobium location.

“80m of high-grade niobium from surface is an outstanding result and demonstrates the world-class status of the niobium mineralisation at St George’s Araxá Project.

“With mineralisation open in all directions, we still have not found the limits of the system. Further large step-out drill holes are planned in the area of the new discovery and we expect to see even more mineralisation uncovered.

“This new zone of high-grade niobium is shaping up as a priority area for a potential mining operation at Araxá given the very high-grade niobium mineralisation that commences from surface. The potential commercial advantage of mineralisation starting from surface cannot be underestimated. It is a significant point of difference between St George and other niobium developers where mineralisation starts 50m or even 100m or more from surface.

“None of the global superpowers has a domestic supply of niobium. In the US, niobium is a top 10 critical metal and rated as number 2 in potential impact to the US GDP if the US is denied supply. China also has no domestic supply of niobium and relies on imports from Brazil.

“This creates an enviable position for St George’s Araxá Project – a world-class high-grade niobium resource with very favourable project logistics given the likely amenability of mineralisation to open-pit mining and access to existing infrastructure in an established mining region. “

Expansion drilling delivers another discovery

The latest assays are from expansion drill holes in the northern section of the project area, and to the west of the existing MRE footprint. This area has never been drilled before.

The confirmation of high-grade niobium 400m west of the MRE is a significant discovery. Just as important is the location of this discovery nearly 1.2km north of the existing measured and indicated component of the MRE as this signals potential to discover and establish other coherent high-grade zones of mineralisation that could be mined separately to the resource in the south.

St George’s strategy was to complete broad-spaced (200m – 400m) step-out drilling in this north-west area of the tenement to further outline the scope of mineralisation. The successful discovery of high-grade mineralisation from surface will now be followed-up with further step-out drilling to the north-west of the discovery hole as well as infill drilling to support inclusion of resources in the MRE update.

We believe the potential for continuation of the high-grade mineralisation to the north-west corner of our tenement is very high. The increased drill density of the resource definition drilling could also identify thick, high-grade niobium and rare earths mineralisation consistent with what we see in other parts of the mineral system where infill drilling has been completed.

MRE upgrade

Although drilling will continue indefinitely into 2026, we are aiming to upgrade the MRE based on drilling completed this month. This will enable an MRE upgrade to be issued in Q1 2026.

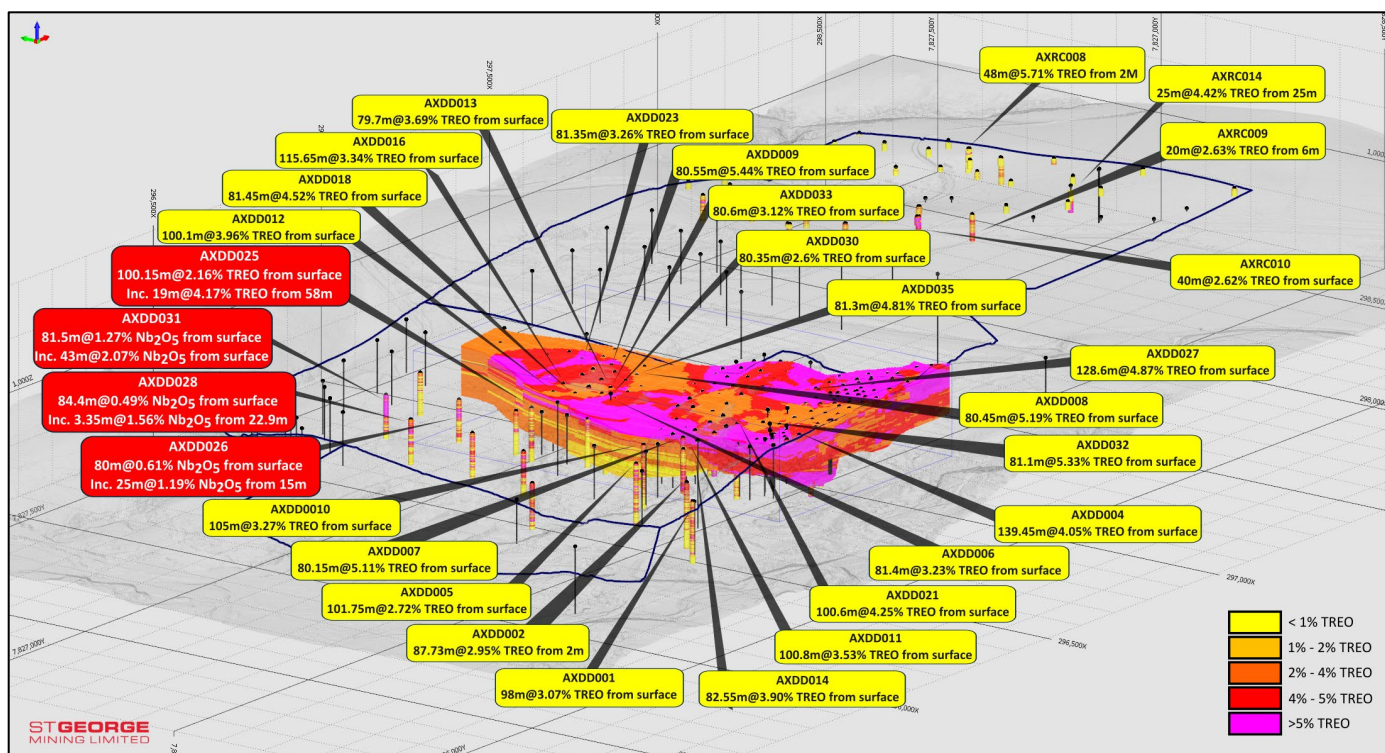


Figure 1 – oblique section showing the latest diamond drill holes as well as other significant drilling completed in the current campaign. The latest drill holes with red labels.

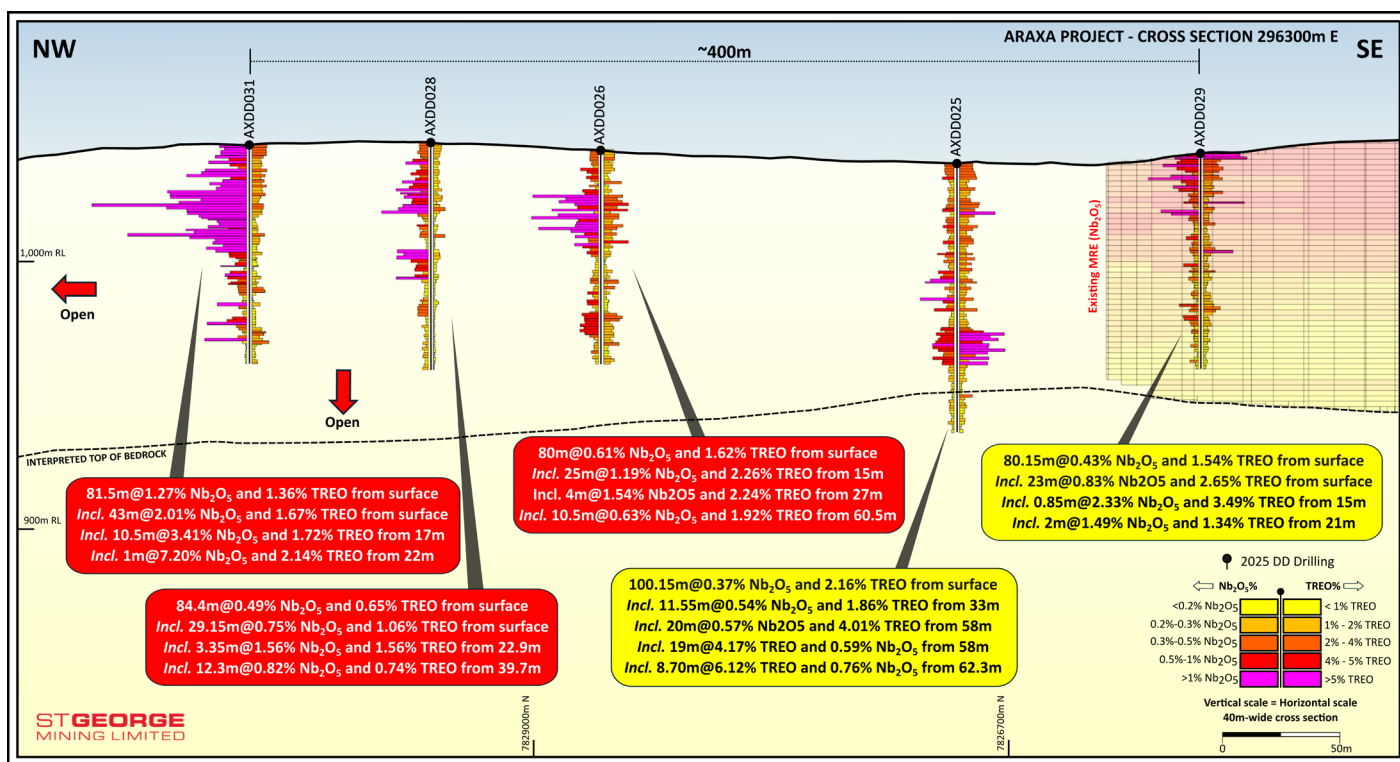


Figure 2 – section showing high-grade Nb₂O₅ intercepts (cut-off 0.2% Nb₂O₅) and TREO (cut-off 1% TREO) high-grade along with the existing MRE outline, showing the westward expansion of the existing MRE.

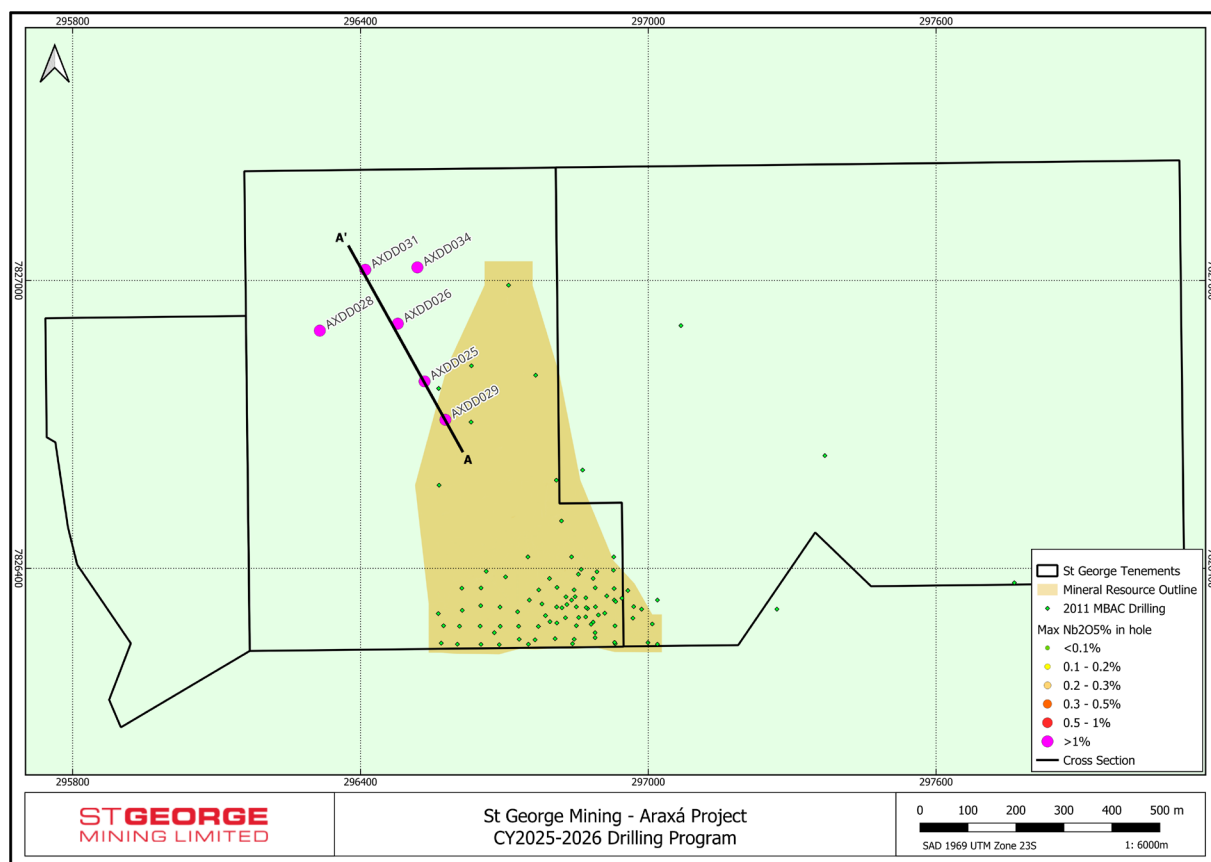


Figure 3 – plan view map of Araxá area showing the location of the diamond drilling relative to the MRE, and the section in Figure 2 above.

Critical Metals – Niobium supply security risk

Niobium is a strategic material used as a superalloy to make lighter, stronger steel and is also essential in aerospace, military hardware, nuclear reactors and a range of electronics.

The US Department of Interior's Top 10 critical minerals includes niobium as well as five rare earths elements that are hosted at the Araxá Project – samarium, lutetium, terbium, dysprosium and gadolinium.

Niobium is rated by the Department of Interior as number 2 in strategic importance among all critical metals given the adverse impact on the US GDP if the US was denied supply. Neither the US nor China has a domestic supply of niobium, emphasising the high risk of supply security for these superpowers.

Brazil currently produces more than 90% of world niobium production, stamping the country as an important global player in critical metals. St George's Araxá Project – with its world-class resource and potential expedited pathway to development – has potential to provide a new source of sought-after niobium, creating strong investor interest.

Existing REE mineralisation extends into new niobium discovery zone

In addition to the high-grade niobium discovery, the latest results confirm that high-grade rare earths (REE) are also present within the new discovery area, representing a significant extension of the existing REE mineralisation. Notable REE results from these latest drill holes include:

- 100.15m @ 2.16% TREO from surface in AXDD025 including
- 19m @ 4.17% TREO from 58m

These findings reinforce the increasing scale of the high-grade mineral system at the Araxá Project and suggest significant potential for a multi-commodity resource increase, encompassing both niobium and rare earths, in the upcoming Q1 2026 MRE upgrade.

St George acquired 100% of the Araxá Project on 27 February 2025. Araxá is a de-risked, world-class rare earths and niobium project in Minas Gerais, Brazil, located adjacent to CBMM's world-leading niobium mining operations.

The region around the Araxá Project has a long history of commercial niobium production and provides access to infrastructure and a skilled workforce.

St George has negotiated government support for expedited project approvals and assembled a highly experienced in-country team and established relationships with key parties and authorities in Brazil to drive the Project through exploration work and development studies.

St George has been selected to participate in the Federal Government's MagBras Initiative – a program aimed at establishing an integrated and sustainable rare earth products supply chain including the production of permanent magnets entirely within Brazil – and has signed a cooperation agreement with the State of Minas Gerais in October 2024 pursuant to which the State will assist in expediting permitting approvals for the Araxá Project.

On 1 April 2025, St George announced a maiden Mineral Resources Estimate (MRE) for the Project, which represents both a globally significant niobium and rare earths resource as shown in **Table 4** below:
