ABOUT THE GOLD POINT PROJECT

Nelson has executed an agreement to earn up to a 90% interest in the Gold Point Project in the Tier-1 mining jurisdiction of Nevada, USA. The Gold Point Project covers 31 km² of claims near the historic mining town of Gold Point, an area with endowment of over 40Moz Au within a 90km radius. Reported pre-WWII production at Gold Point is ~75koz Au at an average grade of 20–30g/t, largely produced from only four of fifteen currently mapped high-grade gold-silver veins (refer to ASX announcement dated 11 December 2025). This is complimented by never-before recognized Au-Cu-W skarn and Cu-Mo-Au porphyry targets, opening multiple new discovery frontiers at the Project. Nelson has recently completed a placement raising \$3.25M to drive exploration activity at the Gold Point Project.
