

# Mining Operations Commence at Mt Dimer Taipan Gold Project, WA

## Highlights

- Mining operations have officially launched at Mt Dimer Taipan Gold Project
- Toll Treatment of ore set to begin in March 2026
- Project fully funded under a Right to Mine Agreement<sup>1</sup> with MEGA Resources:
  - MEGA Resources to fund up to A\$18.6 million in non-dilutive capital
  - Zero upfront costs to EMC with operational cash flow reimbursing expenses and net surplus shared 50/50
- Mt Dimer Taipan hosts an Inferred Mineral Resource of **722kt @ 2.10g/t Au (48,545oz gold) and 3.84g/t Ag (89,011oz silver)**<sup>2</sup>

Everest Metals Corporation Ltd (ASX: **EMC**) ("**EMC**" or "**the Company**") and partner, MEGA Resources Pty Ltd ("**MEGA**") are pleased to confirm that mining operations have begun at Mt Dimer Taipan Gold Project ("**Mt Dimer**"), located 150 km northwest of Kalgoorlie and 120 km northeast of Southern Cross in Western Australia.

This marks the culmination of efficient groundwork, including the recent resource upgrade drilling, propelling Mt Dimer into active production phase.

### EMC's Executive Chairman and CEO Mark Caruso commented:

*"In under four months from receiving final approvals we've transitioned from exploration drilling to active mining – a clear demonstration of our team's execution capability and the strength of our MEGA partnership. With mining now underway and toll-treatment on the horizon, Mt Dimer is perfectly positioned to deliver near-term cashflow in a very strong gold market".*

Under the October 2025 Right to Mine Agreement (RTMA), MEGA is delivering up to A\$18.6 million in non-dilutive capital to advance the project. With site preparations completed and the mining fleet fully mobilised, ore extraction is now progressing on schedule since late November 2025. Toll-treatment at a Kalgoorlie<sup>1</sup> facility (200,000 tonnes per annum capacity) will follow in March 2026, creating a streamlined, fully funded pathway from initial mining, through to processing, and transition into production.

## MT DIMER TAIPAN PROJECT




Figure 3: Mt Dimer Gold project location map

The Mt Dimer Mining Lease (M77/515) has a long exploration history since 1992. EMC acquired the project in 2020, including exploration tenement (E77/2383) that adjoins to the west of M77/515 (Figure 3).

A Maiden Inferred Mineral Resource Estimate (JORC Code 2012) for the Mt Dimer-Taipan Gold and Silver Project – **722kt @ 2.10g/t Au for 48,545 ounces of gold and 3.84g/t Ag for 89,011 ounces of silver** – was reported in 2021<sup>3</sup>, using a cut off 1.0g/t Au for resource sitting below the 380mRL (Table 1).
