### Worley awarded contract for H<sub>2</sub>East Pipeline: Humber to Nottinghamshire in UK

**Worley Limited (ASX: WOR)** ("Worley") has been awarded the Front End Engineering Design (FEED) and Development Consent Order (DCO) contract for the H<sub>2</sub>East Pipeline: Humber to Nottinghamshire project in the United Kingdom by Cadent Gas Ltd (Cadent).

Having previously delivered technical feasibility and pre-FEED services for the project, Worley under the new contract will provide project management, project integration, engineering and design services to support FEED and DCO development. The H<sub>2</sub>East Pipeline: Humber to Nottinghamshire will construct new infrastructure to deliver low carbon hydrogen across the North East, the Humber region, Yorkshire and the East Midlands, connecting key industrial hubs and supplying hydrogen to heavy industry including steel, chemical and power generation.

The network is expected to enable up to 11 gigawatts of hydrogen production capacity, supporting significant emissions reduction and economic benefits across the region, with operations targeted to commence in 2033.

Angie Needle, Cadent's Director of Strategy stated, "Cadent is delighted that Worley has been awarded the FEED contract for H<sub>2</sub>East: Humber to Nottinghamshire. This award builds on the strong foundations laid through the successful pre-FEED routing and design work, ensuring the project is positioned to support government ambitions for hydrogen in the years ahead. Worley's proven expertise makes it an exceptional partner, and Cadent is excited to continue working closely with the team to drive this important project forward and deliver a successful outcome."
