Farm Pride Foods Limited (ASX:FRM)

QUARTERLY ACTIVITIES REPORT AND APPENDIX 4C

Farm Pride Foods Limited (“**Farm Pride**”, “**Company**”) is pleased to provide the following update to shareholders for the quarter ended 31 December 2025 (“**Quarter**”).

During the Quarter, the Company had net operating cash inflows of \$4.566m, including net receipts from customers of \$32.560m. Receipts were 3% higher than the previous quarter primarily driven by increases in farm production, processing efficiency and external egg supplies.

The Company continued to enhance its farming, biosecurity, production and grading operations by investing in infrastructure with \$2.585m of cash outflows from investing activities. The practical benefit of the improvements in operating standards and efficiencies was highlighted by achieving the highest standard of audit result from Coles, one of our key retail partners for our Keysborough grading facility.

Market conditions changed significantly during the later part of the Quarter, with industry egg volumes increasing rapidly placing pressure on pricing. Combined with higher costs this led to a challenging operating environment.

In order to mitigate these pressures and costs, the Company remains focused on capital expenditure and operational improvements to increase efficiency and reduce costs.
