	<p>The Company has a loan facility available to it provided by Bizzell Nominees Pty Ltd an entity associated with the Company's Chairman. The facility at 31 December 2025 was for up to \$7.5 million, Interest rate on drawings is 8%, and the facility was repayable on 31 January 2026 and is unsecured. As at 31 December 2025 the facility was drawn to \$nil. Subsequent to the end of the Quarter, the facility maturity date was extended to 31 March 2027 with a reduced facility limit of \$2,000,000. No funds have been drawn on the facility since the end of the Quarter.</p> <p>The Company has a loan facility provided by Norfolk Enchants Pty Ltd, an unrelated third party. The facility principal was for up to \$6m, has an interest rate of 20% per annum and is currently due for repayment. The facility is secured by a fixed and floating charge over the assets of the Company. As at 31 December 2025 the amount due on the facility was \$2,300,000 and no further amounts are currently available to be drawn under this facility. Further principal and interest payments of \$350,000 have been made by the Company since the end of the Quarter with an agreed repayment plan in place for the remaining loan balance.</p>

Answer: The Company recommenced gold production activities in the prior quarter and expects to generate material cash operating surpluses from its ongoing mining and processing activities from the initial processing campaign which includes the processing of previously mined and stockpiled material. The Company has generated cash surpluses from its operations since the end of the last quarter and the Company's cash balance as at 30 January 2026 is \$2,175,000.

8.8.2 Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer: The Company anticipates that proceeds from gold and silver sales in the current quarter will be sufficient to fund its operations.

Answer: Yes. As noted above, the Company recommenced gold production activities in the prior quarter and expects to generate material cash operating surpluses from its ongoing mining and processing activities from the initial processing campaign which includes the processing of previously mined and stockpiled material.
