Highlights

- DTI commences deliveries of ruggedised NVRs to Rio Tinto;
- DTI signs multi-year maintenance contracts with PTA Rail and Alstom Barcelona trams;
- DTI receives order for 100 NVRs from system integrator in Poland; and
- DTI's cash equivalent balance at the end of the December 2025 quarter was \$0.523M.

DTI Group Limited (ASX:DTI) ("DTI" or "the Company") is pleased to provide its Appendix 4C for the quarter ended 31 December 2025 (Q2 FY26) along with the following operational update.

DTI commences ruggedized NVR deliveries Rio Tinto

DTI Group is pleased to announce that in December 2025 we delivered the first 25 ruggedised NVRs to Rio Tinto. The project is on track to complete all deliveries before the end of the financial year.

DTI wins multi-year maintenance contracts

DTI has entered a 5-year \$517,862 contract with the Public Transport Authority of Western Australia for the ongoing maintenance of its passenger information and surveillance hardware and software installed on the metro and regional rail fleets.

DTI EMEA has also entered into a 3-year €156,300 contract with Alstom for the ongoing support of its CCTV system installed on the new trams in Barcelona.

Eastern European integrator wins multiple contracts utilizing MDR-7

DTI's long term integration partner in Eastern Europe has won multiple CCTV projects for trams and buses. This has resulted in an order for an additional 100 x MDR-7 on-board servers on top of the 120 units already delivered in the first half of FY26.

In accordance with Listing Rule 4.7C.1, during the quarter, the Company recorded \$3.41M in receipts from customers, expended \$2.5M in product manufacturing and operating costs, \$0.89M in staff costs, \$0.21M in administration costs and \$0.07M in other costs.

In accordance with Listing Rule 4.7C.3, \$71,509 was paid to related parties in the quarter for director and company secretarial services as included in the Appendix 4C and section 6.1.

DTI Chief Executive Officer Matt Strack said:

"During the December quarter, the Company continued to progress contracted work, including the commencement of ruggedised NVR deliveries to Rio Tinto and the execution of multi-year maintenance agreements with PTA Rail and Alstom. These contracts support the ongoing performance and



sustainability of DTI's installed systems and provide greater revenue visibility. The additional order from our Eastern European integration partner reflects continued demand for our MDR-7 platform. With deliveries progressing to plan, DTI remains well positioned to complete current projects and pursue further growth opportunities in the second half of FY26."
