**Second quarter update and cashflow**

**Highlights:**

**30<sup>th</sup> January 2026** – IoT solutions company, Constellation Technologies Limited (ASX: CT1) (the “Company” or “Group”) is pleased to provide a summary update on its activities for the quarter ending 31 December 2025.

***Operational Highlights***

During the December quarter, the Company continued to execute its growth strategy by expanding its deployment footprint within the Compass Group contract, extending beyond existing sites into defence-aligned facilities, aged care environments and hospital campuses.

This expansion reflects increasing adoption of the Company’s IoT monitoring and digital compliance solutions across complex, multi-site and campus-based operations where continuous monitoring, compliance assurance, and operational reliability are critical.

In parallel, the Company issued multiple quotations to additional aged care operators and hospital groups, building a strong and well-qualified enterprise pipeline. These opportunities are being actively progressed with the objective of converting them into contracted, multi-site deployments.

***Financial Snapshot***

The Company recorded customer receipts of \$509k during the quarter, reflecting continued engagement from key enterprise clients and sustained recurring revenue from its food-safety and monitoring portfolios.

The Company maintained a disciplined operating structure, with net cash used in operating activities decreasing to (\$69K) for the quarter, while strategically increasing its investment in hardware production to support the rollout of key products for the current and future quarters. The Group ended the quarter with cash reserves of \$374k.

Related party cash payments for the quarter were \$83k and consist of salary related payments for CEO, Kartheek Munigoti; director’s fees to two of the Company’s three non-executive directors and office rental and legal fees paid to entities associated with Mr Nicholson. No cash payments have been made to Mr Malone for his directors fees to date.

The board thanks all shareholders for their continued support and interest in the Company.
