## Contract awards totalling \$75m

- Awards received totalling \$75m
- Works in Western Australia, New South Wales, and the ACT

### Awards

Southern Cross Electrical Engineering Limited (“SCEE Group”) is pleased to announce that various subsidiaries have received a range of awards totalling \$75m as follows.

#### **CITIC Pacific - Sino Iron Project**

SCEE Electrical has been awarded a new two-year Master Services Agreement (“MSA”) by CITIC Pacific Mining Management Pty Ltd to provide electrical maintenance and repair services in the Milling Area at the Sino Iron Project in Western Australia. The award continues SCEE Electrical’s long standing relationship with CITIC Pacific Mining at the Sino Iron Project, where SCEE Electrical has operated under successive MSAs since 2015.

#### **Taylor Construction Group - Data Centre Works**

Taylor Construction Group Pty Ltd has awarded Heyday four further packages of electrical works at a hyperscale data centre in Sydney’s west. Commencing with the original base building contract, these four further awards will bring the total number of packages that have been awarded to Heyday at this site to ten. The works on these four new packages are due for immediate commencement and are scheduled for completion in November this year.

#### **Multiplex - Canberra Lyric Theatre**

In the ACT, following award of the early enabling works, Heyday has now been awarded the main electrical, communications, and security package for the new Canberra Lyric Theatre under a design and construct contract with Multiplex Constructions Pty Ltd. The new Lyric Theatre will seat up to 2,000 people and will incorporate contemporary audience facilities, an all-electric design, and architectural lighting including a coloured façade illumination. Construction works are scheduled to commence in early 2026 and will complete in July 2028.



## **Richard Crookes - Sydney Distribution Centre**

Richard Crookes Constructions Pty Limited has awarded Force Fire the fire services contract for the base building construction and the integrated fit out of a 100,000 sqm distribution centre in south-west Sydney for a major retail chain. The omnichannel fulfilment centre will provide high-density pallet storage, flexible carton-level storage and an automated storage and retrieval system.

Force Fire's scope is to design and construct the fire services for the entire facility, comprising sprinkler systems, detection and alarm systems, hydrants, hose reels, portable fire extinguishers, and interfaces with other services including smoke fans, BMS, PA, and security systems.

Force Fire have commenced on site, with the base building scheduled for completion mid-2026 and fit out works continuing through to the last quarter of 2027.

### **Comment**

Commenting on the above, SCEE Group Managing Director Graeme Dunn said "I am pleased to be announcing this series of awards which again demonstrates the geographic diversity of the group and the breadth of sectors to which it is exposed.

I further note how many of these packages are repeat works for either a particular client or at a particular site which is clear evidence of the quality of delivery of these group businesses."
