## ASX Announcement

**HALO Technologies Holdings Ltd (ASX: HAL)** ('HALO' or 'The Company') today released its results for the full year ended 31 December 2025.

### Refocus on APAC Growth and UK Strategy Realignment

Following the appointment of CEO Peter Oxlade on 3 October 2025, HALO refined its strategic direction with an increased emphasis on Australian and APAC growth, alongside a restructuring of its UK operations.

#### UK Transition to a Capital-Light B2B Model

HALO transitioned its UK business to a capital-light, technology-only B2B model, generating immediate and ongoing financial benefits:

- \$4.2 million in direct UK cost savings
- \$1.8 million in indirect Australian cost savings
- \$1.3 million additional capital injected into the UK business during FY25

This strategic repositioning significantly lowers operating costs and capital requirements while sharpening focus on scalable B2B partnerships.

#### Product Expansion: Managed Funds Launch

In November 2025, HALO launched Managed Funds in Australia, providing financial planners with access to a near-complete universe of Australian managed funds.

This complements the platform's existing offering of 30,000+ global equities and ETFs, materially enhancing HALO's value proposition and expanding its addressable market within the financial planning sector.

#### Financial Performance - Revenue and Earnings

- Operating revenue: \$16.0 million (FY24: \$19.04 million) — down 16%
- Underlying EBITDA loss: \$10.93 million (FY24: \$10.65 million)
- Net loss after tax: \$17.41 million (FY24: \$14.54 million) — up 16%

The decline in revenue driven by:

- Volatility in advisor numbers among B2B clients
- Lower brokerage activity, particularly in the first half
- Broader market volatility influenced by geopolitical tensions and US trade policy

Importantly, higher-margin subscription revenue remained consistent with FY24 levels, demonstrating resilience in recurring income streams.

### **Asset Impairments**

During the year, the Group identified impairment indicators relating to certain intangible assets and conducted a review in accordance with AASB 136.

As a result:

- The UK licence asset (\$1.0 million) was fully written off
- Capitalised software of \$3.76 million was also fully written off

Total impairment recognised: \$4.77 million

These adjustments reflect the strategic repositioning of UK operations and a more conservative balance sheet approach.

### **Funds Under Management (FUM)**

FUM declined from \$434.4 million to \$384.9 million over the 12 months to 31 December 2025.

The reduction was largely attributable to market volatility and softer trading conditions.

The Company continues to strengthen both direct and third-party distribution channels, including onboarding additional Australian dealer groups, which are expected to support future FUM growth.

### **Outlook**

HALO will maintain its focus on:

- Expanding its B2B network across Australia, Asia Pacific, and the UAE
- Growing its subscriber base
- Leveraging the Managed Funds capability to target traditional financial planners
- Executing partnership discussions currently underway with local and international financial institutions

The Company expects to provide further updates upon execution of definitive B2B agreements.
