

Notice Pursuant to Section 708A(5)(e) of the Corporations Act

Brazilian Critical Minerals Limited (ASX: BCM) (“BCM” or the “Company”) gives notice pursuant to section 708A(5)(e) of the Corporations Act 2001 Cth (‘the Act’) that on 10 March 2026, it has issued 1,520,834 fully paid ordinary shares on the conversion of options.

In accordance with section 708A(5)(e) of the Act, the Company gives notice that:
