**PAYMENT DETAILS UPDATE**

**Beam Communications Holdings Ltd** (ASX: BCC, “Beam” or the “Company”) is encouraging shareholders to check that their banking and personal details are up-to-date, following our recent announcement on the proposed share capital return (subject to shareholder approval)<sup>1</sup>.

The quickest and most efficient way for eligible shareholders to receive the payment in their preferred currency is through Electronic Funds Transfer (EFT). As such, all shareholders are strongly encouraged to review and confirm that their EFT/banking details held by the share registry (MUFG) are current and correct through the following three steps:

**Step 1: Confirm your EFT or banking details**

All shareholders are requested to review and confirm that their EFT or banking details held by MUFG are current and correct. Banking details can only be updated online via [MUFG’s Investor Centre](#).

If no valid banking details and preferred currency (where applicable) are recorded, payment will be issued by AUD cheque to the registered address on file.

If an EFT payment is rejected or returned by the receiving bank, Beam will arrange for payment to be made by AUD cheque to the registered address on file.

If your registered address is outside Australia, it is particularly important that you ensure your bank account details and preferred payment currency are up to date with MUFG.

**Step 2: Confirm your registered address**

Please ensure your registered address recorded with MUFG is current and correct. Updates must be made online via [MUFG’s Investor Centre](#).

**Step 3: Confirm your email address for communications**

To receive shareholder communications electronically, please ensure your email address is recorded with MUFG.

Email communication preferences may be updated online via the Investor Centre or by completing and returning the [Communications Preference Form](#).

This form does not update your banking details. Banking changes must be made via MUFG Investor Centre.

Please refer to the [“Update your details online”](#) guide for further step-by-step instructions.

Final details of the capital return timetable will be included in the Notice of Meeting. A tentative timetable was outlined in our ASX announcement dated 27 February<sup>1</sup>.

This announcement has been approved by the Board of Directors.
