EXTENSION OF NON-BINDING MOU WITH HOLCIM AUSTRALIA

Zeotech Limited (ASX: ZEO, “Zeotech” or “the Company”) is pleased to advise that it has received confirmation from Holcim (Australia) Pty Limited (“Holcim Australia”) to extend its collaboration under the terms of the existing non-binding Memorandum of Understanding (“MOU”) announced on 28 October 2024¹.

The expiry date of the MOU is extended to 1 March 2027 and may be terminated by either party upon 30 days’ written notice.

The extension supports the parties’ continued co-operation to advance the commercialisation of AusPozz™ high-performance, high-reactivity metakaolin and facilitate further concrete trials.

Holcim Australia and New Zealand, Head of Technical and Commercial Contracts, Frank Knippers, commented:

“Holcim Australia looks forward to continuing its collaboration with Zeotech to advance the technical evaluation of AusPozz™ and support the development of innovative building materials.”
