## **Strata Investment Holdings plc**

### **Date and place of Incorporation, and Application of Takeover Provisions**

- a) The Company was incorporated in England on 6 April 2001, originally as Capcon Holdings plc, with a name change to Brady Exploration plc on 26 October 2011, thereafter a name change to Metal Tiger plc took place on 16 June 2014, and finally a name change to its current name Strata Investment Holdings plc took place on 19 **April 2023**.
- b) The Company is not subject to Chapters 6,6A, 6B and 6C of the Australian Corporations Act dealing with the acquisition of shares (including substantial shareholdings and takeovers).
- c) With the cancellation of admission of the Shares to trading on the AIM Market of the London Stock Exchange together with the Boards view that the central place of management and control is no longer located in the United Kingdom, Strata Invest Holdings plc is no longer subject to the City Code on Takeovers and Mergers (the Code).
