

## Correction to Previously Released Appendix 2A

**Nova Minerals Limited** (Nova or the Company) (ASX: NVA, Nasdaq: NVA, FSE: QM3) advises that the Appendix 2A — ‘Application for Quotation of Securities lodged with ASX’ on 16 November 2025 contained an error in the number of ordinary fully paid shares applied for quotation.

The error arose because the relevant warrant exercise funds had not been received by the Company at the time the Appendix 2A was lodged. As a result, the Appendix 2A included securities in respect of which the exercise consideration had not yet been received.

The following table sets out the details of the correction:

The Company has notified ASX of this error and confirms that only 80,100 ordinary fully paid shares (being those shares for which valid exercise consideration of A\$0.1806 per share was duly received) should have been included in the Appendix 2A lodged on 16 November 2025.

The 39,900 shares included in error (in respect of which exercise funds were not received) should not have been the subject of an application for quotation at that time.

This announcement is released to clarify the securities issued on exercise of warrants (ASX: NVA AV). All other information in the Appendix 2A remains unchanged.
