## NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS ACT

On 9 April 2026, Lachlan Star Limited (**ASX: LSA**) (**LSA** or the **Company**) completed Tranche 1 of the Placement as announced to the market on 1 April 2026. The Company has therefore issued 60,000,000 fully paid ordinary shares in the capital of the Company (**Shares**) at an issue price of \$0.12.
