NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS ACT 2001 (CTH)

On 17 April 2026, QX Resources Limited (**Company**) completed the issue by way of placement of 46,000,000 fully paid ordinary shares in the capital of the Company (**Shares**) at a price of \$0.005 per Share. The placement was previously announced on 3 February 2026.
